Emergency Drought Funding Available Now!

The Washington State Legislature has appropriated \$16 million to help relieve drought hardships Statewide. The 2015 Drought Emergency Grant Program is administered by the Department of Ecology and a call for projects is open now.

Eligible applicants: public entity, such as a city, town, county, special purpose district, or Tribal entity.

Eligible uses:

- Modify an existing water source or deepen an existing groundwater well.
- Develop an emergency or alternate water source.
- Purchase or lease water or water rights to be used during the drought.
- Construct an emergency intertie or connection to another approved public water supply.
- Build transmission pipelines, diversion structures, or storage devices, and acquire pumps and accessories for moving water.
- Detect and repair leaks, and line water canals.
- Implement emergency water conservation programs and education programs to alleviate hardships from water shortages

Match: 50 percent funding match, except for those public water suppliers that meet the fiscally disadvantaged standard in <u>Chapter 173 -167-040(2) WAC</u>. Deadline: January 1, 2016.

Application Accepted YVCOG and Partners Will Receive Some Specialized Outreach Assistance

In June, MPO's across the state were informed of a technical assistance opportunity through a Federal Highways Administration (FHWA) contract by a group called Community Transportation Association of America. On the announcement for their Call for Applications they noted that their "...assistance is focused on helping these [rural or small-urbanized] planners with their identified issues of stakeholder involvement in planning processes, whether it's reaching out to low-income and minority communities as part of compliance with federal EJ guidance, carrying out public involvement as part of the more routine work of smaller MPOs, helping states with strategies of local officials' cooperation in statewide transportation planning, or simply helping build specific capacities in regional planning organizations in those states where these exist." Whew!

So, of course, what immediately came to mind was one of the projects that will be in the upcoming MPO/RTPO Long-range Transportation Plan – the East-West Corridor connecting Terrace Heights (County) to the City of Yakima (City) over I-82 (WSDOT) and the Yakima River.

On July 1st, YVCOG received a "you've been selected" letter from CTAA for assistance with public outreach to Terrace Heights on one end of the East-West Corridor and the City of Yakima neighborhood north of Lincoln and east of 1st St. on the other end. The CTAA team will provide assistance on how to coordinate all the partners not only involved with the project itself but including those responsible for regional planning. And, we will be able to build the skills of those receiving the training to use throughout the Yakima region. What a wonderful opportunity!

"Guaranteed Ride Home to the Rescue."

I hate to imagine how often this scenario takes place: the carpool/vanpool is loading up for the ride home and poor old Bob runs out and announces, "The boss just told me I have to work overtime; now, how the heck will I get home?" Or Julie, who religiously rides the bus to work, is informed that "Little Suzie" had to come home from school because she is sick and mommy needs to be home with her. Unfortunately, Julie has no idea how she will get home.



Well, the solution to their problems is here, in the form of the Guaranteed Ride Home (GRH) program. The GRH program ensures that participants that utilize an alternative commute mode to the single occupancy vehicle (SOV) such as carpool/vanpool, public transit, walking or bicycle are covered in the case of an emergency. The Commute Trip Reduction (CTR) program, here at the YVCOG, funds a program that guarantees a ride home for those participating employees of employers affected

by the CTR program. We are announcing the award of the GRH contract to a new provider, MEDSTAR Transportation, beginning this month. In fact, MEDSTAR Transportation is the same company that provides Dial-A-Ride and the Guaranteed Ride Home program for Yakima Transit.

It is ironic that survey after survey indicates that employees rank the availability of GRH as the most important influencing factor in their choice to participate in using a commute alternative. The ironic thing is that GRH is so under-utilized. It is rarely, if ever used, yet it is considered an important safety net that allows a comfort zone for those participating in the CTR program. This is a reminder to all of our Employee Transportation Coordinators (ETCs), you need to make your employees aware of this **opportunity** (gosh, I love that word). Posters, brochures and informational flyers, as well as the ride vouchers for the program will be distributed to your worksites shortly. If you are an ETC and you need more vouchers or additional information about Guaranteed Ride Home, call me, e-mail me, and hound me. This is an important program that encourages your employees to use commute alternatives and it costs them nothing. So the next time an employee says "Now, how am I going to get home?" You can respond, "Not to worry, GRH to the rescue."

Department of Ecology Combined Funding Cycle:

The Washington State Department of Ecology FY 2017 Combined Funding Cycle opens August 17, 2015 and closes October 16, 2015. This funding cycle includes the Centennial Clean Water grant program, the Clean Water Act Section 319 grant program, the Revolving Fund loan program, and the Stormwater Financial Assistance grant program. A Water Quality Program workshop will be held in Ellensburg on August 19, 2015 (details: http:// tinyurl.com/WQ-Workshop-Ellensburg). Department of Health Drinking Water State Revolving Fund (DWSRF)

Emergency Loan: Effective July 8, 2015, water systems are able to apply for emergency funding of up to \$100,000 to cover emergency recovery activities. More information: http://tinyurl.com/EmergLoan-15

Construction Loans: For the 2015 loan cycle, loan applications will be accepted from September 1-30, **2015**. Applicants need an approved water system plan, a small water system management program, or plan amendment containing the proposed DWSRF project, to be eligible

Preconstruction Grant: Preconstruction grants help small public water systems (serve 10.000 or less) evaluate the feasibility of seeking a DWSRF infrastructure loan. The next preconstruction grant cycle will be January 2-31, 2016.

Complete Streets Grant Program Funded

The Complete Streets Grant Program, created in 2011, has now been funded. The program has received \$106 million statewide and will be administered by the Transportation Improvement Board. According to the 2011 legislation, the Complete Streets Grant Program will fund street retrofit projects that include "the addition of, or significant repair to. facilities that provide street access with all users in mind, including pedestrians, bicyclists, and public transportation users."

To be eligible, local governments must have adopted a jurisdiction-wide complete streets ordinance "that plans for the needs of all users and is consistent with sound engineering principles."

YVCOG has been working with jurisdictions across Yakima County to adopt just those types of ordinances. So far, Grandview, Sunnyside, and Union Gap have adopted complete streets ordinances, and other jurisdictions are considering them. Our assistance is available until September 30, 2015 to assist any Yakima County city or town with developing and adopting a complete streets ordinance, at no cost to the jurisdiction. 
