“You’re going to work *where?*! What do they do?” That was the universal reaction that I heard from friends, family, and co-workers when I shared the news that I was headed to the YVCOG.

If you’re reading our newsletter, you probably have a basic understanding of what we do. You know that we prepare the regional transportation plan, and we assist you with comprehensive land use plans under the Growth Management Act. We’ve been known to help you land a grant or two, as well. At least, I hope you know these things about us.

My sense is that YVCOG functions in a sort of ‘middle space,’ between our member jurisdictions and state and federal agencies. This space doesn’t offer much in the way of direct contact with our region’s citizens. Citizen contact is important because that’s the primary channel through which you, as local elected officials, hear about local problems. That channel is also one that YVCOG can use to explain how we help local governments improve the quality of life for the residents of our region.

What’s a COG for? If I were to reduce our reason for existence to one phrase, I’d return to our founding legislation: We are a regional forum to solve problems. As I mentioned at a recent hearing, “We’re in the solution business.” You define those problems and bring them to us for resolution. We help identify problems too, by talking with your staff and attending council meetings. We also attend trainings and events in order to discover new tools, services, or programs that might be effective here in our region.

In 2015, expect to hear more from us about what we do and how we can help. We are here to serve; indeed, that’s why the YVCOG was created!

Legislative Session

At over two weeks in, the 2015 Legislative Session is in full swing for our local lawmakers. There are several bills that have been introduced in both the House and the Senate that could have interesting implications for Yakima Valley jurisdictions. Did you know that there are 14 bills (10 in the House, 4 in the Senate) related to marijuana? Of course, there are other topics besides marijuana – there is a bill in the house (HB 1806) related to cost recovery for commercial public records requests. Another interesting bill from the house (HB 1123) would regulate the minimum dimensions for habitable spaces in single-family residential areas.

We will continue to track bills that could impact the Valley and provide additional updates throughout the legislative session.

Dust Off Those Cobwebs ...

It won't be long before spring is in the air, and what a terrific time to dust off the cobwebs that have accumulated on that most efficient of all transportation modes, your bicycle. I'm often asked the question, "What I can do to become more involved in making this community more bicycle friendly?" Often times I don't have all the answers, but I sure know where to find them. I paid a visit to some valuable sources: the Bicycle Alliance of Washington's www.bicyclealliance.org and the League of American Bicyclists www.bikeleague.org websites are treasure-troves of bicycle information.

Here are just 10 things you can do to make your community a better place for bicycling (and walking, for that matter):

1. **Contact your elected officials.** You can phone, write, e-mail or meet with them. Let them know that bicycling is important to you. Ask them to support a particular project, more funding for bicycle facilities, bicycle-friendly public policies, etc.
2. **Attend public hearings that impact bicycling.** Transportation projects, community plans, budgets, land use, regional transit ... these things can affect your ability to bicycle safely and easily.
3. **Join a bicycle organization that advocates for cyclists and encourage your cycling friends to do the same.** Groups like the Bicycle Alliance of Washington can keep you informed about bicycle issues and can help you take action on issues of interest to you. A great local resource is our own Chinook Cycling Club of Yakima (www.chinookcycling.com). A relatively new member of the local bicycle advocacy family is *Yakima Bikes and Walks!* www.facebook.com.YakimaBikes and <https://yakimabikesandwalks.org>
4. **Write a letter to the editor or opinion piece for your local paper.** Keep it brief and timely.
5. **Attend a "bicycle" event.** May is Bike-To-Work-Month and there are many bike-related events throughout the region. Visit the sites above for event information as well as the Yakima Greenway <http://yakimagreenway.org/q2q/> for information regarding "**Gap to Gap**" events.
6. **Familiarize yourself with your community's transportation plan.** These transportation plans must address non-motorized transportation such as bicycling. Use the elements that support bicycling to support your issue.
7. **Contact your local transportation and park officials.** Encourage them to stripe more bike lanes, install more bicycle parking, or fix specific safety hazards.
8. **Sit on your local bicycle/pedestrian advisory committee and attend their meetings.** While the City of Yakima Bicycle/Pedestrian Advisory Committee has been on hiatus for some time now, the group *Yakima Bikes and Walks!* has stepped in to advocate for those who rely primarily on walking and bicycling to get where they are going.
9. **Get involved in your neighborhood or city planning process.** The Growth Management Act requires comprehensive planning at the local, regional and state level — and they address bicycling.
10. **Be a bicycle ambassador.** Promote safe cycling by riding safely yourself. Encourage your workplace and the businesses that you patronize to support bicycling. Spread the word to your friends, family, colleagues and neighbors. Trails and bicycle-friendly streets aren't just a benefit to bicyclists; they are a community benefit as well.

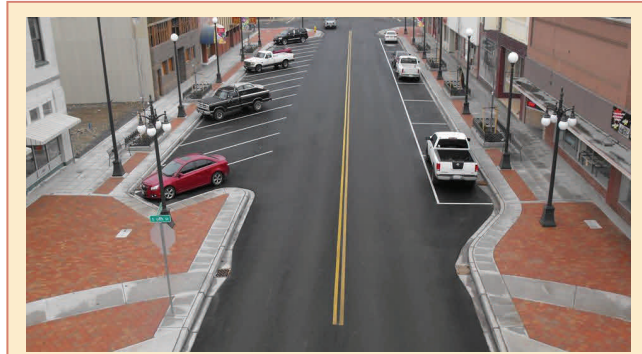

Community Connect Grant Program Open

USDA-RD's annual Community Connect Grant Program helps fund broadband development in rural communities where it is not currently economically viable for the private sector to provide service. Local governments and tribes are eligible. Funds may be used for the construction, acquisition, or leasing of facilities, land or buildings to establish broadband service for residential and business customers, and critical community facilities. Up to 10% of the grant may be used for construction of improvement of a community center that provides online access to the public.
